A thriving city centre and competitively priced, plentiful industrial land with good linkages to the most efficient port in Australasia and strong infrastructure support, significantly contribute to profit margins.

A demonstrated commitment by the education sector to work alongside industry in the region ensures a deep talent pool, including skilled and semi-skilled labour, and is available for your business to draw from. In addition, strong business networks, including capability development and mentoring schemes, proactively support new and established business operators to maximise their business potential.

A full range of commercial properties, many of which are new developments, are on offer across Tauranga and the Western Bay of Plenty. These are designed to suit all manner of businesses from

home-based start-ups, requiring the flexibility to grow year on year, to larger industrial ventures, requiring significant landholdings and services. Innovative co-working spaces in the city centre bring complementary businesses together and we are seeing the establishment of synergistic business hubs, or innovation parks across Tauranga and the Western Bay of Plenty.


The Tauranga Business Case is compelling and the entrepreneurs, business owners and operators who are making the move are reaping the benefits on both business and personal fronts.

Individuals who have moved from Auckland or overseas locations have been able to purchase or build equivalent homes in prime locations across the Tauranga region at lower cost, leaving significant capital for investment in business.

A growing number of businesses in the Tauranga area are located on major routes to the CBD, also providing easy access to the Port of Tauranga and to the airport. With roads over 60% less congested than Auckland, it doesn't matter where you choose to live or work – travelling times to the office, air or sea port are significantly reduced. Tauranga really is a city that allows you to make work/life balance a reality.

The average age of people moving to Tauranga is 25 - 45 years. This younger demographic is rapidly changing the face of the region and Tauranga boasts a high standard of primary and secondary education. Collaboration across schools provides students with access to resources and specialist teachers outside of their enrolled school, and integration with the business community serves as a valuable entry point for many school leavers.

A compelling business case and an attractive lifestyle in a sought after coastal environment - Tauranga really does add up.

A FEW FACTS ABOUT TAURANGA AND THE WESTERN BAY OF PLENTY




Industrial land and commercial properties are attractively priced compared to Auckland and Hamilton

- Over 650 hectares of land is designated for business and industrial zoning in the next few years
- The Government is investing: \$400million+ in the Tauranga
 Eastern Link positioning the city as a major North Island
 hub for road transport
- Tauranga's population is forecast to double within 30 years; one of the fastest population growth rates of any city in New Zealand
- Domestic migration is mainly from Auckland and the Waikato, with 50% of new arrivals between the ages of 25 and 45 years
- The Port of Tauranga is New Zealand's largest and most efficient port. As container volumes continue to increase, the Port has invested \$30 million to extend its capacity to handle new services and more frequent visits from larger ships. A dredging programme has commenced so the Port will be able to accommodate the next generation of container ships
- An increase in the capacity of the Sulphur Point rail terminal will facilitate greater efficiencies for North Island importers and exporters



- There are 21,662 businesses in Tauranga and the Western Bay of Plenty, demonstrating a new business growth rate well above the national average
- Tauranga city centre is growing significantly with waterfront development projects underway and over \$60 million invested in commercial developments in Tauranga's city centre over the past two years



2,400 hours of sunshine

Tauranga has a sub-tropical climate; the average temperature is 14.2°C and the city enjoys about 2,400 hours of sunshine a year, well above the national average

- A CBD university campus, comprising industry aligned research and teaching facilites, is well advanced in planning and will link business and commercial interests with tailored skills programmes
- Tauranga is one the first cities in New Zealand to be connected to the ultrafast broadband network and the first with a free city centre WiFi network



COCKTAILS FROM TAURANGA TO THE WORLD

A simple yet innovative idea to produce pre-mixed, ready-to-serve cocktails has taken the world by storm. And VnC Cocktails are mixed, bottled and exported from Greerton, Tauranga.

VnC Cocktails produces and packages their product at their dedicated global manufacturing facility, which offers ready access to the Port of Tauranga. Currently, over 90 percent of production from the Tauranga facility is exported to over 20 overseas markets, and the market for these ready-to-serve cocktails is expanding year on year.

Global sales of VnC Cocktails are expected to expand rapidly over the coming years. Export volumes are set to quadruple by 2015 and an annual production target of 1 million cases is a realistic goal.

The Tauranga manufacturing facility is well placed to handle this growth, with the capacity to increase from the existing two bottling lines, to four within the current factory footprint. Additional space on the site is already being earmarked for additional storage facilities and future developments.



There are many reasons people choose to run a business, but one thing all business owners have in common is the desire to make a profit. Equally, there are many factors that contribute to increased profit. Setting up your business in Tauranga offers a number of benefits that ultimately translate into a healthy bottom line.

Affordable property


More than 21,600 businesses call Tauranga and the surrounding area home, yet there is still plenty of space for you to build your business. Over 500 ha of commercial land is available now for development across the region and at very competitive prices compared to Auckland and Hamilton. On average industrial land in Tauranga is 55 per cent less than Auckland land value. When it comes to renting business space, the average office rental is 40% lower than Auckland. And that means more cost effective operating costs for you.

Access to markets

Tauranga boasts strong infrastructure that makes doing business easy. National road, rail and air networks make transporting freight to and from Tauranga simple.

What sets Tauranga apart is the number of innovative, high-value, import- and export-focused businesses succeeding in the area. Easy access to the port makes Tauranga the perfect location for these companies. Around 60% of business locations are within a 10km radius of both the Port of Tauranga and Tauranga Airport, and the average travel time across Tauranga to the port is only 15 minutes.

Tauranga is within two hour's drive of 40% of New Zealand's population, and with Auckland, Hamilton and Rotorua nearby, customers, suppliers and partners are within easy reach.

The Government has recognised the importance of managing growth in the area and improving the efficiency of travel time, investing more than \$100 million in developing the Tauranga Eastern Link. At the same time, a significant amount has been invested in the busy East Coast Main Trunk rail line between Hamilton and Tauranga to ensure it can continue to meet increasing customer demand for additional rail freight services.

World-class infrastructure

Ultrafast broadband rollout is well underway and many areas are already connected. Urban rollout is expected to be completed in 2014. The opportunities that fast broadband enables

are endless. Your business could be one of the first to take advantage of these opportunities.

In addition, the Tauranga city centre is now WiFi enabled thanks to a partnership between local service provider EOL and Mainstreet Tauranga. It's the first city centre in New Zealand to offer free public internet access, so business people and visitors can remain connected. You can log on to the Internet using smartphones or other devices at local cafés, restaurants or businesses.



TAURANGA LURES AUSTRALIAN MANUFACTURER

Australian-based manufacturer, FSP Holdings Pty Ltd was established 17 years ago to manufacture equipment for the mining industry and not long after diversified into rotational moulded plastics including lockers and storage equipment.

With a global footprint that now includes manufacturing operations in Australia and China, design and testing facility in Chile and agents/distributors in Kalimantan Indonesia, PNG, Zambia, Mozambique, Belgium and Canada, FSP undertook a strategic review of their operations in 2012.

FSP decided to repurpose the Australian plant and shift manufacturing of the plastics lockers and cabinets offshore. Comparative business cases were drawn up for the location of a manufacturing plant in Indonesia, Thailand and New Zealand. Competitive manufacturing costs, accessibility

and frequency of import and export services, and the availability of skilled labour made New Zealand the most attractive location.

"The New Zealand plant will be responsible for 60 to 70% of the volume of the business and the products will all be destined for the export market," says Kevin Voss, Manager of Business Development at FSP.

When it came to selecting a business location in New Zealand, Tauranga ticked all the boxes. Auckland and Wellington were considered but the ability to secure premises in close proximity to the Port of Tauranga and the services offered were the deciding factors.

"The Port of Tauranga offer a frequency of service to and from Australian and International ports that we just couldn't get from other New Zealand ports.

"The lifestyle location of Tauranga is also an attractive aspect from an employment perspective, as it assists in retention of staff." FSP plan to employ over 20 semi-skilled workers as their plant comes on line.




More often than not, it's the people that make a great place to work. And it's also the right people that make a business succeed and grow.

The Tauranga area is experiencing one of the fastest rates of population growth in New Zealand with many people moving to the area from Auckland and the Waikato. Tauranga city is predicted to almost double in size by June 2051 growing from 103,635 people to 199,400.

Talented workforce

The population in Tauranga is booming and with that comes opportunities for your business.

Tauranga offers an attractive lifestyle for young professionals, and many talented workers are choosing to leave the big cities in search of a better standard of living for their families. These skilled, creative people want to work for innovative businesses that think big and can offer them the chance to develop in their careers.

Businesses are drawing a growing pool of employees to the area, with specialised skills in food technology, processing and manufacturing. And an established seasonal labour pool means that your business can scale up to meet demand when needed.

Education and training opportunities

Tauranga is served by numerous tertiary educational institutions providing opportunities to retrain or upskill. The Bay of Plenty Tertiary Partnership comprising the University of Waikato, Bay of Plenty Polytechnic and indigenous university Te Whare Wānanga o Awanuiārangi, is at the leading edge of industry teaching and research in New Zealand, providing skilled graduates eager to start their careers and offering your business the chance to employ and train them. A proposal is underway to develop a \$67.3 million city centre tertiary and research campus for Tauranga, which will be a centrepiece for regional innovation and entrepreneurship. A business focussed tertiary sector also gives you the chance to invest in your staff's professional development, helping to retain them and bring new skills and the latest thinking back into your business.

Tauranga enjoys a strong culture of business collaboration which stimulates growth and fosters partnerships and new opportunities.

As well as a skilled labour pool, Tauranga also offers a wellnetworked, supportive business community and business-friendly councils, who are there to help make your business a success.

MUSSEL WORKERS RETURN YEAR ON YEAR

North Island Mussels Limited (NIML) is a joint venture between Sanford Limited and Sealord Group Limited. In 2005, processing operations were relocated to Tauranga in order to be close to the Port of Tauranga.

For NIML, a just-in-time mussel processing operation, transportation logistics is imperative. Mussels have to be processed live and strict time requirements are enforced from the time they are harvested to when they are processed and exported.

Mussels are grown on shareholders' farms primarily across the Coromandel and are brought in to the Tauranga facility by truck. During the 8 to 10-month season, the Tauranga based processing plant receives up to 1.8 million mussels (100 tones) on a daily basis. ship Por In 2 fea ma hou mu hou NIN tha low "Ar are so 2 Arc and fac wor our tho ret

Within 24 hours the processed and packaged mussels are being loaded into 40 foot refrigerated containers and shipped to markets around the world through the Port of Tauranga.

In 2010, a \$23 million facility was opened in Tauranga, featuring the world's first automated mussel opening (AMO) machines, developed in New Zealand. The Tauranga factory houses 28 AMO machines that each process up to 3,600 mussels per hour - more than 1.6 million mussels per 16 hour day on optimal product.

NIML is one of Tauranga's largest employers with more than 230 workers. "We're a people-based business, and we love being part of the community here," says Steve Wells. "Around 30 of our workers are permanent, and the rest are seasonal. We run a just-in-time processing business, so access to the right workforce is really important to us. Around eighty per cent of our workers return every year and that's important to us. It's nice to see so many familiar

faces, it builds a strong workplace community and our business benefits from those experienced employees returning, as they know and understand our operations."







Many New Zealanders fondly remember family holidays at Mount Maunganui. Over the years Tauranga has grown and is now a hub for innovative businesses, boasting limitless sporting and recreational pursuits, vibrant arts and cultural experiences and high quality retail centres and community facilities.

People who live and work in the region manage to capture a bit of that holiday feeling every day with their active recreational lifestyle. From kayaking, swimming, fishing and boating, to biking, tramping or golf, there is always something to do, whether you love the ocean, beach, mountains or forest.

There is a choice of quality, affordable housing from new residential estates, to older character homes, lifestyle properties with space for the children and pets to run, or waterfront residences enabling the ultimate in lifestyle opportunities.

The area boasts high quality preschool, primary, secondary and tertiary education with 10 secondary schools providing a mix of coeducational, single sex, religious, state and state integrated education options.

Tauranga also offers a well-serviced public and private health system with state of the art surgical facilities.

The Bay of Plenty Clinical School, established by the District Health Board, supports the training of medical, nursing and allied health students at Tauranga Hospital, Whakatane Hospital and in general practices in the Bay. The Clinical School attracts students from national international tertiary institutions and encourages them to return as employees once qualified.

TAURANGA COMES OUT TOPS FOR FURNITURE SUPPLIER

Morgan Furniture has grown rapidly over the past 65 years into the largest supplier of upholstery furniture in New Zealand including the popular La-Z-Boy brand.

In 2007, the executive decided to review the existing business model and looked to establish a dedicated warehousing and distribution facility with close access to a domestic and international shipping port.

Locations in Auckland, Hamilton and Tauranga were all considered and business cases modelled for suitable facilities or greenfields sites in each city.

Factors such as domestic transportation time and cost, domestic and international shipping volumes, and port access were important components of the business case. As well as business requirements, the team looked at housing prices in each area, schools and community activities.

In 2008 Morgan Furniture acquired a large site in Tauriko Business Estate on the edge of SH29, allowing easy access to all road routes across the North Island, to Tauranga CBD and the Port of Tauranga. Morgan Furniture negotiated a co-location arrangement with their partner freight carrier and constructed a 5,000m² purpose-built facility.

Morgan Furniture has a very loyal workforce with many long serving employees and a number of husband and wife teams. Seven employees jumped at the chance to relocate to Tauranga. Many have since bought houses in the region and are loving life in the Western Bay of Plenty. As part of the team that managed the establishment of Morgan Furniture in Tauranga, these employees are proud to be part of Morgan Furniture's continued growth and success.



Tauranga city centre

Tauranga's city centre is undergoing rapid transformation, making it an exciting place from which to do business. Continued investment and the completion of major building works have changed the landscape and silhouette of the city. Significant investment over the past three years has infused a renewed optimism for Tauranga's economic future, and investors, developers, planners and business entrepreneurs are actively discussing future plans for the city. In the last 18 months there have been a significant number of businesses that have seen the advantages of basing themselves in the city centre, adding vibrancy to the area.

An innovative co-working space, Ignition, has opened in Tauranga's city centre to support early stage entrepreneurs. Offering facilites, services and access to business networks, Ignition provides people the opportunity to plug in, set up and start operating. The co-working space also operates as a stepping stone for businesses as they mature from home offices to professional office suites.

New buildings and upgrades

Over \$60 million has been invested in commercial developments in Tauranga's city centre over the past two years alone stimulating business investment, relocations and economic development.

The \$10.3 million Sharp Tudhope building on the corner of First Avenue and Devonport Road, completed in May 2012, is tipped to be Tauranga's first official 'green star' rated building. A \$21.5 million, five-level building at 247 Cameron Road is now home to KPMG, Cooney Lees Morgan, Aurecon, Staples Rodway and Realty Services.

Earthquake strengthening work continues on over 100 city centre premises to ensure they conform to the most recent building codes. Many landlords and building owners are using this as an opportunity to upgrade buildings and refurbish premises, providing existing tenants and potential occupants with attractive business premises in the city centre.

Waterfront development

Tauranga's waterfront is a natural extension of the city centre. Development work is underway to create an iconic destination that celebrates the city's connection with the water and provides a versatile space that everyone can enjoy.

Linking with art and cultural facilities, the waterfront development provides a special place for families, events, festivals and other leisure activities. Pedestrian and cycle pathways are complete, landscaping and street furniture have been installed along the seawall. An iconic children's playground has recently been completed, providing a unique family space. All this will be complemented by boutique hospitality and tourism offers aligned with the harbour and its surrounds.

Business connectivity

The Tauranga city centre is now WiFi enabled thanks to a partnership between local service provider EOL and Mainstreet Tauranga. In a move that positioned Tauranga as the first city centre in New Zealand to offer free public internet access, business people and visitors can remain connected across Tauranga's city centre.

The rollout of ultrafast broadband across the sub-region is taking place, actively connecting up businesses and residents to the fibre network.

City of the future

Tauranga's City Centre Strategy has been developed for future growth and sustainability, ensuring that Tauranga continues to attract and retain business and talent, creates high value employment and stimulates economic growth.

The unique Bay of Plenty Tertiary Partnership, involving the University of Waikato, Bay of Plenty Polytechnic and Te Whare Wānanga o Awanuiārangi, is driving the development of a tertiary precinct in Tauranga's city centre.

The opportunity currently exists to showcase Tauranga's city centre and surrounds to domestic and international guests and conference delegates with an international hotel in the heart of the city.

In addition, the creation of a premier urban living environment

in the inner city will add significantly to the vibrancy of Tauranga city centre, attract investment and talent, increase retail spend, stimulate cultural events and activities, and encourage the development of key commercial sites.




Business opportunities

Tauranga businesses are known for innovation and there are plenty of research and development opportunities in the area.

The University of Waikato is one of New Zealand's major research organisations with significant national and international research and development links. The University is particularly strong in marine sciences, business management, computing and mathematical sciences and education.

The University hosts regular workshops and symposiums for local businesses, featuring the latest presentations and research from local and international scientists and offering opportunities to work together in applied research for commercial growth.

The Bay of Plenty Tertiary Partnership, between The University of Waikato, Bay of Plenty Polytechnic and Whare Wānanga o Awanuiārangi, is working to develop a city centre tertiary and research campus for Tauranga. The proposed campus will be the first of its kind in New Zealand, delivering a university experience in partnership with a polytechnic and wānanga.


The concentration of agricultural and food based businesses in Tauranga and the Western Bay of Plenty lends itself to research into these areas, and Plant & Food Research has a base in the area. The organisation has recently joined with The University of Auckland to create the Joint Graduate School in Plant and Food Science. The school gives postgraduate students the opportunity to undertake masters or PhD research of direct relevance to the New Zealand primary production and food industries, often while working in and applying their doctoral research to local businesses.

As well as having access to the latest scientific research, your business can also benefit from a concentration of specialised graduates.

In the metal and manufacturing industries, the Titanium Industry Development Association (TiDA) is at the leading edge of titanium based products using powder metallurgy consolidation processes. TiDA has recently received \$7 million in funding from the Ministry of Business Innovation and Employment towards commercially focused research in high tech manufacturing. The Bay of Plenty Polytechnic offer New Zealand's only diploma in engineering with a powder metallurgy specialisation.

The Bay of Plenty Clinical School administers undergraduate student placements and clinical training for the Bay of Plenty District Health Board which provides primary and secondary healthcare services to over 200,000 people in the Eastern and Western Bay of Plenty. The school also has a Clinical Trials Unit that provides resources and support for clinical trials and research projects.

These, along with research opportunities with Massey University, the Ministry of Business, Innovation and Employment, Callaghan Innovation and other research bodies, equal competitive growth for your business.



HIGH-TECH BUSINESSES ON THE UP

James Graham operates a successful and growing custom electronics and software design and production business in South Africa, but a search for specialised electronic design engineers led him to Tauranga.

Through Priority One, James was linked into a network of professional services that helped him establish the New Zealand office of Multifid Technology International Ltd in Greerton.

"Tauranga is a place of future growth and I can only see it becoming a very big city over the long term," says James. "It's exciting to be based here right now at the cutting edge, and watch as the high-tech sector grows in leaps and bounds."

Focussing on the research and design of innovative safety and security products for the transport and heavy industrial sector (mining, forestry, container handling), Multifid is now looking to take their products into production and establish a production facility in Tauranga.

This next phase of growth for Multifid will bring employment opportunities for many more electronic design engineers and production teams.

James Graham has partnered with others to establish a second company, Toi Mata Ltd. The company is involved in the sales, marketing and distribution of Multifid products as well as products from small companies needing this facility in a "share and grow" model.





SPECIALISED INDUSTRY SECTORS

Tauranga is already home to a vast number of high-value, import- and export-focused businesses. Building your business alongside them gives you the chance to share resources, expertise, technology, research and marketing.

Horticulture, value-added food production, aquaculture and bioactives

Tauranga and the Western Bay of Plenty has an exceptional growing climate, making it perfect for horticulture and agriculture as well as aquaculture and fishing. Innovative businesses have added value to these industries through further production, processing and technology. Tauranga is now known as one of the country's top food production areas and a significant exporter of high quality food products.

The Bay of Plenty food industry currently employs more than 9,000 people and has sales of more than \$6,020 million per annum, of which over \$500 million is for food processing alone. In recent years the industry has grown by 17.5 per cent in value of sales, 10 per cent in employment and 49 per cent in exports.

Aquaculture has been identified as a key sector for growth in the wider Bay of Plenty. Research by Bay of Plenty Regional Council found local waters among the most productive in New Zealand. It has been estimated the Bay of Plenty aquaculture industry has the potential to reach \$250 million in export sales by 2025.

Tauranga is becoming a developing hub for food manufacturers and there are many R&D opportunities with research organisations and other local food production businesses.

A horticultural innovation park has been established at Te Puna, known as Newnham Park. It is home to a number of innovative food and horticultural companies such as PlusGroup Horticulture, Heilala Vanilla and Kiwifruitz Limited. These businesses join forces to work on R&D projects and strategies to maximise export potential of their food products.

A similar campus is being planned for Paengaroa on land adjacent to Comvita's head office, visitor centre and production facility. The Comvita Campus Zone is expected to attract like-minded businesses in the food, bioactives and natural products manufacturing sector.

Information and Communications Technology (ICT)

The information and communications technology sector offers a high-value opportunity to help grow the local as well as New Zealand economies. It is a key enabler and driver of productivity as well as providing links in global value chains and creating high value revenue opportunities.

ICT is a key focus area for Tauranga and the Western Bay of Plenty. Facilitated by Priority One, the local ICT cluster brings together more than 540 members from over 220 ICT and related businesses. These businesses aim to create commercial opportunities and contribute their experience and expertise to the development of an IT rich area. This sector has experienced significant growth locally in recent years.





The Bay of Plenty ICT strategy sets a path for the region to achieve significant growth in the development of niche ICT products and services.

Several specialised software houses have already developed products to support the region's main sectors: horticulture and transportation, distribution and logistics. There is also a strong export focus for ICT products.

The area attracts top ICT graduates from the University of Waikato and Bay of Plenty Polytechnic who developed a Bachelor of Arts (Computing Science) to meet the specific needs of the local ICT industry.

An innovative co-working space, Ignition, has opened in Tauranga's city centre to support early stage entrepreneurs and has attracted a significant number of ICT based businesses. Web developers, designers, digital marketing consultants, and cloud based accounting and software consultants are all enjoying the benefits of a flexible working environment. Designed to nurture business growth and connect people into established networks, Ignition is proving to meet the needs of small business operators in Tauranga and the Western Bay of Plenty.

Marine

The Tauranga area is globally recognised as home to some of the world's best boat design and construction firms. The local marine industry is involved in the building, designing, sales, storage and servicing of pleasure and commercial boats, including international racing yachts.

Tauranga's facilities cater for the manufacture of composite yachts, including all design, electrical, engineering, stainless steel, upholstery, joinery and cabinetmaking. The most modern production technologies are combined with the finest of traditional craftsmanship to produce leading edge vessels. A purpose built boatstack at Sulphur Point has storage for up to 200 boats.

The Tauranga Marine Industries Association is a cluster group of local companies from across the marine industry. The cluster works with

members to grow their businesses through networking, referrals and sharing technical expertise. The combined resources of the cluster provide world class marine services extending to luxury yacht and commercial fleet operators.

Specialised manufacturing

Specialist manufacturing companies are focusing their attention on Tauranga and choosing to base their operations, and grow their businesses here.

Established companies in Tauranga produce products for both the domestic and international markets - from aluminium ducting and solar panels and systems, through to buses and luxury coaches, dentistry tools and equipment, and automatic door and manual watertight and weathertight door closures in the high-end marine sector.

New manufacturing businesses are attracted by this well-established network of existing businesses, which are open to sharing their knowledge and developing mutually beneficial partnerships.

For companies with an import or export focus, the proximity of the port and airport is a key business benefit, enabling products to be sent overseas quickly and efficiently. The strong rail and road infrastructure allows supplies and materials and finished products to move in and out easily.

The area offers a mix of commercial, light and heavy industrial zoning, with premises available to suit diverse manufacturing needs.

Business owners find a steady supply of skilled labour in Tauranga. The Bay of Plenty Polytechnic recognises manufacturing as a strong and growing sector with training programmes designed to support local businesses and produce graduates with skills that are in high demand.

Distribution, supply chain and logistics

Tauranga is located in the centre of the north island and is home to New Zealand's largest port by volume, with an annual cargo throughput of more than 18.5 million tonnes. The area is also dominated by thriving manufacturing and horticultural sectors, with a significant export focus. This makes it a centre for transportation, distribution and logistics.

Along with Auckland and Hamilton, Tauranga is located within New Zealand's 'golden triangle', which is responsible for around 65 per cent of the country's freight movements. Tonnes of freight move in and out of Tauranga daily, and a relatively high proportion of people are employed in the transportation and logistics sector.

Strong growth is projected in this area over the next 20 years, when it will comprise over half of New Zealand's total economic activity and 53 per cent of its population.

The local ICT cluster has developed leading edge distribution and logistics software to support the sector and it continues to develop innovative initiatives.

Another advantage for the region as New Zealand's distribution and logistics hub is Smart Transport Corridors, the region's transportation plan. This has been specifically designed to facilitate the smooth movement of traffic to and from the port, both within Tauranga and the Western Bay of Plenty and between the area and other major centres.



STRONG TRANSPORT INFRASTRUCTURE

Tauranga's coastal location in the centre of the North Island, makes it the ideal place to reach, whether you're travelling by boat, car, truck, train or aeroplane. This easy access has many advantages for your business.

The Port of Tauranga

The Port of Tauranga is at the heart of the city, a hub for business and international trade. Many businesses in the area have a strong export focus, and easy access to the Port is crucial to their success. The Port of Tauranga takes the title of the country's largest port in terms of gross export tonnage. It has direct access to New Zealand's largest import market and well-developed sea, road and rail connections.

The Port of Tauranga offer a range of cargo gateways and shipping solutions, not only in the Bay of Plenty but also in Auckland, Northland and various ports throughout New Zealand.

The Tauranga Eastern Link

The government is investing in developing the Tauranga Eastern Link, a key strategic transport corridor for the region. This 23km, four lane highway from Te Maunga to Paengaroa that bypasses Te Puke is one of the government's seven Roads of National Significance.

When complete, the Tauranga Eastern Link will support the growth of Tauranga and the Western Bay of Plenty, further improve business productivity and efficiency through improved travel time, provide a more direct route to the Port of Tauranga and improve safety.

Tauranga Airport

Tauranga Airport provides convenient access to other parts of the country and is less than a fifteen minute commute from the CBD at peak hour, a significant advantage for the business commuter.

The airport links Tauranga with cities around New Zealand and makes it easy to connect with an international flight to do business abroad. It offers daily direct flights to Auckland, Wellington and Christchurch, and connections to all other areas.

East Coast Main Trunk Railway

This freight line runs between Hamilton and Kawerau, serving several Western Bay of Plenty towns including Omokoroa, Te Puna, Tauranga, Mount Maunganui, Te Maunga, Papamoa, Te Puke and Paengaroa.

Recently an investment of \$500,000 saw a passing loop developed on the line, providing greater flexibility and increased capacity for carrying freight. The loop doubles the line's capacity from two trains an hour to four trains an hour.
